The meeting was called to order by Mayor Tedford at 7:00 p.m.

Mayor Tedford led the Pledge of Allegiance.

City Clerk Cordes explained that Mr. Randy Shores, the manager for Golden Gate Petroleum/S.E.T. Retail of Nevada, has applied for a restricted gaming license for seven (7) slot machines at Golden Gate/S.E.T Retail of Nevada located at 1755 West Williams Avenue. Golden Gaming will be the slot route vendor. The owner of record for this business is Golden Gate Petroleum/S.E.T. Retail of Nevada. They currently hold a City of Fallon business license and an off-premise liquor license. The application has been reviewed by City Engineer Souba, Deputy City Attorney Erquiaga, Police Chief Gehman and City Clerk Cordes; they have recommended approval.
