Adoption of Resolution No. 17-19: A resolution authorizing the Adjustment of Allowance for Doubtful Accounts – Enterprise Fund Account Receivables in the amount of \$61,399.32

City Clerk Cordes explained that, for fiscal year July 1, 2015 to June 30, 2016, \$19,158,576 was charged to utility customers of the City of Fallon for the services of electric, water, water treatment, sewer, sanitation, and landfill. Out of the \$19,158,576 billed, we have been unable to collect \$61,399.32 or less than 1/5 of 1%. These accounts are a year old. The balance due to the City of Fallon have been turned over to a collection agency, have had liens filed on the property, or the customer has filed for bankruptcy. This adjustment does not prevent future collections to occur. This adjustment tonight provides for the proper accounting in our financial statements. He recommended adoption of this resolution.

Mayor Tedford reminded that this is less than 1/5 of 1%, which is very low.

Mayor Tedford inquired if the Council had any comments or questions.

Councilwoman Frost inquired as to the meaning of "upon off" under the collection code on the list submitted with the resolution.

City Clerk Cordes explained that is when a landlord arranges to have the utility responsibility transferred into their name when they are between tenants. He was unsure why the landlords are on this list, but he will follow up.

Mayor Tedford inquired if there were any public comments or questions.

No public comments were noted.

Councilman Erickson motioned to adopt Resolution No. 17-19: A resolution authorizing the Adjustment of Allowance for Doubtful Accounts – Enterprise Fund Account Receivables in the amount of \$61,399.32; seconded by Councilwoman Frost and approved with a 3-0 vote by the Council.

Resolution No. 17-20: A Resolution authorizing the execution and delivery of an installment purchase agreement in an amount of up to \$270,000 for the purpose of acquiring a police department radio system to be used by the City's police department; authorizing the officers of the City to execute the installment purchase agreement and other documents related to the installment purchase agreement; and providing the effective date hereof

Deputy City Attorney Leonard Mackedon explained that this resolution will authorize the execution and delivery of the installment purchase agreement in the amount not to exceed \$270,000. This is for the purpose of purchasing a police radio system to replace the current system that has gone well beyond its useful life and cannot be efficiently repaired in any manner

due to technological changes. During the May 16, 2017 Council meeting, the Council authorized the negotiation of the terms of that contract. This resolution is the authorization for the execution of that contract.

Mayor Tedford noted that this keeps us from having to front load all those costs. We are in need of this radio system. This is important for public safety.

Chief Gehman added that we are well past end of life for our current radio system and this seems to be our best option.

Mayor Tedford inquired if the Council had any comments or questions.

Councilwoman Frost inquired as to the timeline for installation of this radio system.

Chief Gehman advised that it would hopefully be sometime in September.

Mayor Tedford inquired if there were any public comments or questions.

No public comments were noted.

A couple months ago he visited with the City Engineer and asked him to look at Front Street between Maine and Humboldt Streets because he believed that stretch is probably one of the worst in the City. A few weeks later some of the potholes were filled, he knew that the area could not be repaved on a whim, so he thanked the City for the work they did and asked that the area be considered for further work in the future. It is becoming very narrow and it is sometimes difficult for two cars to pass.

Mayor Tedford stated that this has been a project that he has discussed with staff; they have driven it repeatedly. This is not a straightforward project; the side streets that connect are difficult due to elevation. Portions of Front Street were in the county for a long time, some are now part of the City. He has tasked staff with working out a solution. Councilman Erickson has a lot of history as a previous Mayor too. He also sits on the Regional Transportation Commission where we allot road tax funds to redo these streets. We are not sure if it is a \$400,000 to \$500,000 project; that is what we are exploring, because that entire area needs to be redone. He assured Mr. Jackson that it is definitely on our mind and on our radar. We want to do the entire area as a project and do it right; it would improve the entire neighborhood for the residents. We think that small section you are referring to did not get done because it was in the county; but we did another section because there was a water line that was replaced. Mayor Tedford believed that it is a good, worthwhile project and appreciated Mr. Jackson's comments.
