DISCUSSION: The City of Fallon issued its Electric System Revenue Bonds, Series 2017 in October 2017 in order to complete a number of electric enterprise capital improvement projects including the design and construction of a new 4<sup>th</sup> electric substation, to be known as the New River Substation. The New River Substation project includes the required components associated with the construction and interconnection of a new 60 kV substation, located at the corner of New River Parkway and Wildes Road. Upon completion, the New River Substation will increase the reliability of the City of Fallon's electrical system while decreasing the current demand on the Babb Street Substation and provide capacity for future growth and development at the City's New River Business Park.

Construction elements of the project include, but are not limited to, site work, ground grid installation, fencing, foundations, transformer installation, regulators, metering cabinets, and station commissioning.

BACKGROUND: This project was released for public bid on October 30, 2019 and advertised in the Lahontan Valley News in accordance with NRS 338.1385. A pre-bid meeting was held on November 14, 2019. Three bids were received and publicly opened by the City of Fallon on


December 3, 2019. With approval, construction would start in January of 2020, with a 134-day construction schedule.

### **Declaration to Abandon Sewer Utility Easement**

The CITY OF FALLON, a political subdivision of the State of Nevada, by action taken by the Fallon City Council, as hereinafter set forth, does hereby recite and declare as follows:

### **RECITALS**

- 1.) KENNETH KENT, ROBERT KENT and THOMAS D. KENT (KENTS) conveyed an easement to the CITY OF FALLON on June 23, 1954 to allow for the installation of sewer line infrastructure lying within and across the boundaries of real property owned by KENTS.
- 2.) The sewer easement referred to in paragraph 1 above was memorialized in a document that was recorded on July 14, 1954 as File No. 80246 at Page 329, Book 31 of Deeds in the Official Records of Churchill County, Nevada which purported to describe the alignment of the easement conveyed to the CITY OF FALLON (hereinafter referred to as 1954 CONVEYANCE).
- 3.) The legal description in the 1954 CONVEYANCE incorrectly described the actual, true, physical alignment of the sewer line as it was actually constructed and as it was intended to be constructed by the CITY OF FALLON and by KENTS.
- 4.) E&C SCHANK PROPERTIES, LLC, a Nevada Limited Liability Company, is the present owner of the property described in the 1954 CONVEYANCE and also the owner of the real property over and across which the sewer line serving the sewer utility owned and operated by the CITY OF FALLON actually physically traverses.
- 5.) The CITY OF FALLON and E&C SCHANK PROPERTIES, LLC have agreed that E&C SCHANK PROPERTIES, LLC shall to grant the CITY OF FALLON a 30' sewer utility easement that properly describes by survey the correct location of the sewer easement within which the sewer infrastructure is installed and within which maintenance and repairs may be conducted by the CITY OF FALLON.
- 6.) The Fallon City Council has determined, for the reasons stated herein, in a regular and properly noticed meeting of the Fallon City Council on the \_\_\_\_\_ day of December 2019, that the 1954 CONVEYANCE purporting to create a sewer easement to serve the sewer utility of the CITY OF FALLON does not in fact benefit the CITY OF FALLON or its citizens and should be abandoned.

#### **WHEREFORE**

The CITY OF FALLON, by action taken by the Fallon City Council as aforesaid, declares that, all rights conferred by the 1954 CONVEYANCE, shall be deemed abandoned and forever extinguished effective as of the date that the Mayor of the CITY OF FALLON shall have signed this "Declaration to Abandon Sewer Utility Easement."






## 2019/2020 Total Incidents Reported








