RECOMMENDED COUNCIL ACTION: Motion to suspend or revoke the liquor license of Leah Vahl at Leah's Bar, 165 S. Maine Street, Fallon, Nevada, for non-payment of utility bills.

### **DISCUSSION:**

Pursuant to FMC 5.08.170 a hearing must be held before the city council can take action to suspend or revoke a licensee's liquor license. If it appears to the satisfaction of a majority of the city council, at the time of hearing, that the licensee failed to pay their utility bill when due, the city council can revoke or suspend the licensee's liquor license.

FMC 5.08.170(D) provides that if the licensee fails to file a written answer within 5 days after being served with the complaint and fails to show up for the hearing the city council shall order the license revoked.

If the licensee shows up at the hearing and the city council determines suspension of the liquor license is appropriate, the suspension of the liquor license must be for a minimum period of thirty (30) days from the date of the entry of the city council's order.

In the event the license is revoked, no license shall be issued to the licensee for the operation of an establishment where alcoholic beverages are sold for a minimum period of one (1) year from the day of the entry of the council's order. The licensee may apply for a liquor license after the expiration of the revocation term.

Complaint and Possible Suspension or Revocation of Liquor License.

Dear Ms. Vahl,

Re:

Pursuant to Fallon Municipal Code ("FMC") 5.08.160, your liquor license may be suspended or revoked by the city council for failure to pay your utility bills from the City of Fallon when due. See FMC 5.08.160(I). This letter serves as a complaint against you and to notify you that you will have five (5) days from the date of the service of this complaint to file a written answer to the complaint, under oath, with the City Clerk located at 55 W. Williams Avenue, Fallon, Nevada. See FMC 5.08.170(B).

A liquor license in the City of Fallon is a privileged license that may be suspended or revoked by the city council when it appears to the satisfaction of a majority of the city council that the licensee has failed to pay their utility bill when due. According to the City of Fallon Clerk's Office, you-as the licensee-have failed to pay your utility bills when due. Specifically, you are in arrears on your utility bills in the amount of \$6,575.26 as of the date of this letter. Since April 30, 2020, you have paid a total of \$600 towards your utilities.

You will have five (5) days from the date of the service of this complaint to file with the City Clerk a written answer to the complaint, under oath. FMC 5.08.170(B). The city council will set a date and time for a hearing and the notice of the hearing will be served upon you. FMC 5.08.170(C). If you fail to file a written answer within five (5) days after service of this complaint or if you fail to appear at the place and time designated for the hearing, the city council will order your liquor license revoked. FMC 5.08.170(D).

In the event the city council suspends your license, the suspension shall be for a minimum of thirty (30) days from the date of the entry of the city council's order. If your license is revoked, no license shall be issued to you-as licensee- for the operation of an establishment where alcoholic beverages are sold for a minimum period of one (1) year from the day of the entry of the city council's order, *FMC* 5.08.180.
