The meeting was called to order by Mayor Tedford at 9:00 a.m.

Mayor Tedford led the Pledge of Allegiance.

Mayor Tedford inquired if the agenda had been posted in compliance with NRS requirements.

Deputy City Clerk Elsie Lee advised that the agenda was posted in compliance with NRS requirements.

#### **Public Comments**

Mayor Tedford inquired if there were any public comments. He noted that comments are to be general in nature, not relative to any agenda items. No action may be taken on a matter raised under this item until the matter has been specifically included on an agenda as an item upon which action will be taken.

Mr. Geoff Knell of 261 Serpa Place greeted the Council stating that he would like to repeat the communist goals (attached for the record) step 27 infiltrate the churches and replace revealed religion with "social" religion. Discredit the Bible and emphasize the need for intellectual maturity which does not need a "religious crutch." Our seminaries have been infiltrated. attached to this cover sheet. This agenda item represents the public's opportunity to comment on the proposed ordinance and to present relevant information and materials to the Council.

Mayor Tedford inquired if the Council had any questions for Mr. Zimney.

Councilwoman Kent inquired if this was the same code that Churchill County and Fernley are following.

Engineer Zimney informed her that it is.

Councilwoman Frost stated that she is aware these are updated often. She asked when we think the next update would be.

Engineer Zimney stated that he would expect that in the next year or two they might come out with the 2021 or 2022 codes. I think there is always a lag until the Northern Nevada amendments of the Northern Nevada Code Council goes through everything, updates everything. Our Building Inspector, Gary Johnson is on that Board. He hasn't heard any rumblings of the most current ones coming out yet. I would anticipate it is going to push that we won't want to wait so long next time, but it isn't in our best interest to remain on the 2012 any longer.

Mayor Tedford asked the Council if they had any further questions.

No comments were made.

Mayor Tedford inquired if there were any public comments.

Mr. Geoff Knell of 261 Serpa Place addressed the Council. Do you know what the B system is? Well, I am going to educate you on it. But first, I am going to read the scripture, II Corinthians 11:14-15 - 14 And no marvel; for Satan himself is transformed into an angel of light. <sup>15</sup> Therefore it is no great thing if his ministers also be transformed as the ministers of righteousness; whose end shall be according to their works. 1 John 4 - Beloved, believe not every spirit, but try the spirits whether they are of God: because many false prophets are gone out into the world. 1 Peter 5:8 Be sober, be vigilant; because your adversary the devil, as a roaring lion, walketh about, seeking whom he may devour: For this agenda item here we can look at it from a biblical perspective. Councilwoman Kent inquired on the implementation of the codes. I understand most of the contractors in the City are familiar with building in the County with their current codes. Are most contractors in the City already building with this code? Is this going to go in effect immediately, or are they given a timeframe to abide by?

Engineer Derek Zimney informed the Council that they will be sending out letters giving them about one month to update to the code. For most of the local contractors building houses, they are already using the higher installation codes. They are already using a slightly better window requirement, there is extra outlets in the garage, there is a list of things. Most of them are already using the current codes. They are already drawing houses into the 2018 code. The major differences have already been mostly implemented. We are giving a month grace period and then we are requiring the 2018 codes.

Councilwoman Frost inquired if by adopting these, it will help our ISO rating.

Engineer Derek Zimney informed the Council that the City of Fallon is a separate rating. The ISO for the Fire Department, the ISO-1, is specific to the Fire Department and a combination of our water system. We have a different rating for the houses. I don't know if they score the same way, but we have a high rating. To keep that constant, we have to update these codes and be on a current code to maintain our evaluations.

Mayor Tedford asked Derek if the answer is yes.

Engineer Zimney replied, yes.

Councilwoman Frost stated, thus our insurance rates stay lower for all our citizens in

our community.

Councilman Richardson commented that when we update our codes, in general, it provides a home that is more energy-efficient by having more outlets in a certain area is probably more of a safety thing. If there is not enough outlets and the homeowner, or tenant, is trying to plug in multiple appliances. Would you say these upgrades are more to improve energy consumption and safety?

Engineer Zimney stated that he would absolutely say so.

Mayor Tedford asked the Council if they had any further questions.

No comments were made.

Mayor Tedford inquired if there were any public comments.

Mr. Geoff Knell of 261 Serpa Place addressed the Council. Under this stress of what you are following through maybe asking questions. You are living in temp servitude. You are letting the Federal Government persuade you to go along with this. This is the international ICC is a non-profit, you don't have to join it, but it sounds so good. You let money dictate, awe it sounds great, oh and improve our structure, but that takes away our own individuality, or own businesses. #### American Jewry Meets the Challenge

EXTENSION OF REMARKS OF

#### HON. EUGENE J. KEOGH

OF NEW YORK

IN THE HOUSE OF REPRESENTATIVES

Thursday, January 10, 1963

Mr. KEOGH. Mr. Speaker, under leave to extend my remarks in the REC-ORD. I include the following address by Mr. Louis H. Solomon on September 28, 1961, at a dinner meeting of the New York University Jewish Culture Foundation, marking the beginning of the campaign to erect a Center for Jewish Culture at New York University.

Mr. Solomon, a trustee of the New York University Jewish Culture Foundation, is a distinguished attorney. He is a graduate of New York University and a noted leader in many civic activities. He is well known among business and community leaders as the head of the Greenwich Village Chamber of Commerce.

His tribute to American Jewish leadership follows:

AMERICAN JEWRY MEETS THE CHALLENGE (Address presented by Louis H. Solomon on September 28, 1961)

There has been a great deal of provocative discussion of late on the subject of the role of Judaism and the Jew in Judeo-Christian world society. Too much of the discussion is a veiled attack upon the devotion of the Jew to the heritage and traditions that define his status as an identifiable, ethnic personality in a Christian-dominated world and his re-sistance to pressure for assimilation.

The discussions acknowledge, sometimes with evident reluctance, frequently with ex-travagant generosity, the importance of Judaism in world culture, as the source of the Judeo-Christian religions, and the essence of Judeo-Christian ethical philoso-phy. Yes, they say, the Jew has given to mankind the Judeo-Christian religions. He has given Jesus to Christianity. He has provided the concept of justice and the sense of social responsibility which make up the meaning of Judeo-Christian ethical philosophy. But the whole mood of the discussion radiates the sentimental regret that the Jew remains unchanged in his determined status as a Jew, as a separate, identifiable creature, loyal to Judaism in deflance of cen-turies of pressure for assimilation.

Toynbee, the English historian, reflects the pronounced assimilationist viewpoint. He projects the argument that the resistance of the Jew to assimilation is responsible in a large measure for the anti-Semitic

posture of the world. In a recent discourse by Toynbee, he acknowledges generous recognition of the Jew for fundamental contributions to world society. He even ventures the regret that the strong traits of the Jew, the character responsible for the miracle of survival and so much of the world culture, that this strain is not available to enrich the other segments of human society. The underlying tone of the Toynbee creed is the covert annoyance of the historian, that in spite of centuries of history, in defiance of the sword and the pen, this remains the heritage of the Jew, a relatively small identifiable group, immune to absorption. On the other hand, is the frustrating regret of the historian, that society as a whole is denied the special strain of character values that persist in the Jew and would be made available to the rest of society by intermarriage and full assimila-

Sometimes one wonders what prompts the persistence of the Toynbee followers to argue for the assimilation of the Jew. What is it that pushes the endeavors of this historian and his disciples so vigorously to bury cen-turies of sacred traditions, to subvert loyalties to faith, to destroy the spiritual potential that has given so much to so many? There is persuasive authority for the premise that all anti-Semitism is a psychoneurosis. the psychologist, "anti-Semitism," so-called, to conceal specific Jew hatred (Judenhass), is not explainable as a rational drive. One is tempted to ask—is the pressure for the as-similation of the Jew but an unrestrained sprout from the same sprig? Is it a symptom of the same complex?

#### THE "INTELLECTUALS"

Contemporaneously with the Toynbee discourse, an article appeared in a recent issue of the magazine Commentary, under the title "Intellectuals" which poses the problem, but with a wide difference in motivation. This article purports to review the attitude on assimilation of the Jew on the college campus. It emphasizes a seeming indifference to heritage and tradition among budding intellectuals.

The intellectuals, so called, are not by any means the sages of our day. Nor do they reflect the mature community judgment. These are students, budding scholars perhaps, living in an environment of challenge, of abstraction and speculation. This is not the climate conducive to respect for tradition or heritage. To them heritage and tradition are related to the dead past. History is important more for its dates than its monuments. They present a pose of for its monuments. They present a pose of pride in sophistication, a sense of revolt against the authority of yesterday. This is a passing phase in the pursuit of wisdom. Sober assessment of spiritual values will come with maturity. They will learn that man does not live by bread alone. Then shall they claim their kinship to the people of the Bible and the treasured heritage of the Torah.

The infamous Nauman group of pre-Hitler Germany is the prototype for a small segment of American Jewish life emphasizing a pose of sophistication, ready to trade heritage and tradition. They do not want to be counted out of the fold, yet they cannot endure minority status, and they spurn affiliation with the "common herd." Devoid of intellectual insight, of moral vigor, of loyalty to tradition, and the capacity to

will improve the burden of taxation in ways that will improve the performance of our economy, but the budget cutlook tells us that unless we exert a much more effective discipline over the volume of Federal spending we cannot undertake these needed measures of tax relief without courting larger and larger deficits. All the evidence points to the need for a searching scrutiny of expenditure priorities.

There is, of course, one of the 67 new Members who needs no introduction to Mrs. Bolton-and that is her son, Congressman Oliver Bolton, whom we are delighted to welcome back to Capitol Hill. The article follows:

GREAT LADY FROM OMIO: Mes. BOLTON (By Alvin Silverman)

Washington.—The passing last week of Mrs. Eleanor Roccevelt and the resulting effusion of tributes to her character and achievements brought to mind the lamentable fact that not until death occurs is very much laudatory ever said about any indi-

Judged by any except the most illiberal of critics, Mrs. Roosevelt was a great waman. There are not many great women around. Their total only slightly exceeds the number of great men.

There is, however, a great woman who is a Clevelander. Since she is very much alive and very much disinclined to toot her own horn, this might be an appropriate time to discuss her.

Her name is PRANCES P. BOLTON.

Congresswoman from Ohio's 22d District since 1940, Mrs. Bourow comes from a dis-tinguished family long associated with publie service. Both of her grandfathers served in the Ohio General Assembly and one of them, Henry B. Payne, became a U.S. Representative and then a Senator.

Mrs. Bourow and her son, Ouver, just elected to the House for another term after sitting on the sidelines for several years while recovering his health, comprise the only mother-son team ever to serve together in the Congress.

Mrs. Borron is regarded as an authority on legislation dealing with U.S. foreign pol-

ioy, particularly Africa and France.
In 1955 ahe made a 20,000-mile study tour of Africa. Her visit to 24 countries south and east of the Schara Desert was the first extensive mission to Africa by a Member of Congress.

Two years later, she returned to Africa as an official delegate to the Ghana independ-ence ceremonies, and later in 1957 she made on official report on United Nation refugee camps in the Middle East. There is not a single important official of

any of the new African nations who does not ider Mrs. Bouron a close friend and adviser. Her Washington home is virtually a headquarters for them when they are in the

Far boyond her contributions in the field of foreign affairs, however, have been Mrs. Bourour's activities in health and nursing. The first Army school of nursing in World

War I was largely the result of the pressure War I was largely the result of the pressure she personally applied on her friend from Cleveland, Secretary of War Newton D. Baker. During World War II, her Bolton bill created the U.S. Cadet Nurse Corps, an or-gainzation that graduated 125,000 nurses for the Nation's war effort. Western Re-serve University's School of Kuraing, named for her, eloquently bespeaks her efforts.

A friend recently was feeling pretty proud that he had been chesen to receive an honcrary doctorate degree from a university. Mrs. Boxrow acted as if she could not have been more thrilled if she had received one herself. If she had, it would have been No. 15 for her.

France awarded her membership in the French Legion of Honor officer class for her

work during and after World War II. Her other awards include "Churchwoman of the Year," and the American Social Hygiene Association's award for distinguished service to humanity.

Mrs. Borrow is vice regent for Ohio of the Mount Vernon Ladies Association, possibly the most exclusive organization in the Nation. For more than a century, it has been in charge of the George Washington National Shrine. Only recently, Mrs. Boxrow bought a large tract of land across the Potomac River from Mount Vernon so that the view would remain unchanged.

There is probably not a church or a hospital in northern Obio that has not been eved in a major crisis by Mrs. Bouron's financial help or other assistance.

All this, of course, does not make her a great woman.

Her greatness comes also from her character and personality and—well, you get the gen-eral idea by now.

Pay Increase for the Military

Mr. BOB WILSON. Mr. Speaker, for many months I have been extremely concerned at the delay of the Kennedy administration in pushing for a pay increase for the military, despite the fact that other governmental employees have benefited from pay raises on two occasions since the last general military pay increase in 1958.

Last fall I pledged to introduce, if necessary, and support legislation calling for a substantial pay increase. Included was to be a section correcting the inequities in the pay scales for those retired personnel who left the service prior to July 1958. These retired persons were discriminated against and a great inequity has existed for over 4 years as a result.

A few weeks ago I was heartened to learn that the Defense Department was supporting a pay increase measure amounting to as much as 14 percent in some categories and also correcting the intequities I mentioned previously.

Rather than introduce my version of a pay bill I have decided to defer such action until the administration's measure comes before the Personnel Subcommittee of the Armed Services Committee. As a member of the subcommittee, I recognize that legislation as introduced by the administration is merely the raw material from which a truly effective and meaningful pay bill can be molded by our subcommittee and subsequently by the Congress.

It is the responsibility of the Congress to act with dispatch on a substantial and constructive pay bill for active duty and retired personnel of our military service and I am looking forward to helping to expedite this much-needed legislation.



Mayor Tedford inquired if the agenda had been posted in compliance with NRS requirements.

Deputy City Clerk Elsie Lee advised that the agenda was posted in compliance with Governor Sisolak's Emergency Directives, the agenda and the supporting materials were posted at City Hall, on the City's website, and the State of Nevada's public notice website on or before 9:00 a.m. May 11, 2021.

Hearing with discussion and possible action pursuant to FMC 5.08.170 to consider suspension or revocation of the liquor license of Leah Vahl at Leah's Bar, 165 S. Maine Street, Fallon, Nevada for non-payment of utility bills

Deputy City Attorney Trent deBraga informed the Council that the Fallon Municipal Code provides a process in addressing City Council to revoke or suspend a licensee's liquor license. Specifically, Fallon Municipal Code (FMC) 5.08.160i allows the City Council to suspend or revoke a liquor license when a licensee fails to pay their utility bill when due. Fallon Municipal Code 5.08.170 provides the process and procedure that must be followed prior to the City Council suspending or revoking a liquor license. The first step in the process requires the initiation of a complaint. A complaint can be filed by any person and contain the alleged reasons for initiating the proceedings. The code also states that the complaint must be served on the licensee. April 23, 2021, the City Attorney initiated a complaint after receiving information from the Clerk's office informing that Ms. Leah Vahl, the licensee of Leah's Bar, at 165 S. Maine Street, was past due on her utility bill. The April 23, 2021, complaint advised Ms. Vahl that her license may be revoked or suspended by Council for failure to pay her utility bill when due, and that her utility bill was in arears excess of \$6,500.00. The complaint initiated by the City Attorney also informed Ms. Vahl that pursuant to the FMC that she had five days from the date of service of the complaint,

to file a written response to the Clerk's office. For the record, the April 23, 2021, complaint was served by the Chief of Police, Kevin Gehman, on April 23, 2021. The City Attorney's office received information that no written response was filed with the Clerk's office by Ms. Vahl. The FMC provides the next step for the process/procedure and that requires the City Council to set a date and time for a hearing, with notice of said hearing to be served upon the licensee. The Council is aware on May 7, 2021, Council held a meeting that set the date and time for today's hearing. The notice of today's hearing was personally served by Captain Kris Alexander and Sergeant Jose Perez, both employed by the Fallon Police Department, on May 10, 2021. The notice of hearing was contained in the letter drafted by the City Attorney's office served on May 10, 2021. I do believe for the record, that Ms. Vahl is present today. Prior to today's hearing, the City Attorney's office has received confirmation from the Clerk's office that Ms. Vahl has become current on her past due utility bills and has paid the amount in full. Based on Ms. Vahl paying the arears in full the City Attorney, as the complainant, would ask the complaint to be withdrawn and recommend to the Council that no action be taken on the agenda item.

Mayor Tedford thanked Deputy City Attorney deBraga and inquired if the Council had any questions.

Councilman Richardson asked if the recommendation is that no action be taken at this time, but if action can still be made even though this is not a withdraw of complaint?

Deputy City Attorney deBraga stated that Councilman Richardson is correct. I do believe that Council does have the option to proceed forward if they so desire. The recommendation would be to take no action which essentially, will allow Ms. Vahl to continue to operate with her license.

Councilman Richardson thanked Deputy City Attorney deBraga.

Mayor Tedford informed that he believes the recommendation from staff and the City Attorney's office is to not take any action because she brought the bill current. They cannot make that decision because they do not act as the Council, so the Council could take action. I agree with them due to the bill being current. I would entertain a motion for Council to take no action. We must take some action because we have a hearing today for the recommendation to be considered. Is there any public comment?

No comments were noted.

Councilwoman Kent commented regarding the bill going past due for months and months. What is the standard procedure when someone becomes past due? This might be pertaining to COVID, but what procedures are in place with similar accounts.

Mayor Tedford informed that there were several issues regarding this situation which includes a cabaret and liquor license, which were paid. We had non-payment of the utilities. Under the ordinance that provides of revocation for a liquor license also. This is a unique situation, unlike a normal business not paying their utility bill, which would result in just turning their utilities off. In this case, because she has a privileged license, not just a utility license, it causes a revocation of that liquor license. Revocation of a privileged license is different than a non-privileged license. I think in the future, and going forward, and for Leah, we most likely will just turn utilities off because she may have her liquor and cabaret license current, but we are not going to fool with this again. She needs to keep that bill current, to go through the steps that we had to do for this is very cumbersome and stressful, not only on her, but it is also pretty cumbersome on the City. Whereas the steps on the utility bill are not taken this far usually. I think because of the pandemic we are attempting to be easier on businesses and residents because of what they are going through with their situation, this may have gone a little further than it should have, and we usually do not go that far. Anyone that is in this position has brought their

bill current or starts the process. Sean and Elsie's office are taking steps to make sure they do so. In my history, we have taken steps to allow people more time to allow their bills to become current because they have put themself in a tight place on occasion. There are times we have had to tell them that we are just going to turn their utilities off and we have had to do it. It is unfortunate, but I have always felt that we must have a level playing field for businesses out there or the residential places that are paying and commercial buildings, are paying the bills for them, and that is not fair. In ordinary circumstances, this does not happen. I do not know if there is a hard and fast rule that you follow Elsie. You are flexible and provide a discount letter, they come in and they work with them. There are occasions that they are supposed to run these situations by me, and extensions are given. Sometimes, they do not run them by me, and they are not supposed to do that without my approval. Unfortunately, on occasion, no offense, they say things in the Clerk's office that are not going to work because I did not give the approval. We have a hard time when that happens, and sometimes they agree to things, and we must tell them that payment agreement is not going to work. Many times, those people come over to my business and have a chat with me because they are not very happy. The end of the year we write off 1/10 of 1% of billings, as you will see when we do them every year. We follow them like a hawk if they ever move into the City. The best way to handle most of these is to turn off the utilities. This one was a unique incident that we hopefully won't have to work through again. The motion I would suggest is to make a motion to take no action. This will keep the record clean, not only for Leah but also as we go forward if a similar situation happens in the future. It doesn't show us just tabling the matter and leaving it floating out there. It would show that the City did take action, but it was just no action.

Councilman Richardson motioned to take no action on the matter to suspend or revoke the liquor license of Leah Vahl at Leah's Bar, 165 S. Maine Street, Fallon, Nevada pursuant to FMC 5.08.170 for non-payment of utility bills; seconded by Councilwoman Frost and approved with a 3-0 vote by the Council.


enhanced that neighborhood. Drive South Maine Street. Thank you, Kelly. No further comments were made.
