The City Council shall hold regular meetings on the first and third Tuesdays of each month, at the hour of 9:00 a.m., unless the City Council, in its discretion, prescribes a different day or time to hold a regular meeting, or prescribes to cancel a regular meeting, so long as the City Council holds at least one (1) regular meeting each month, and gives proper notice of the different day or time or cancellation in accordance with law. When a regular meeting day falls on a legal holiday, the regular meeting shall be held at the same time on the first day that City offices are open next following the legal holiday.
