RECOMMENDED COUNCIL ACTION: Motion to confirm the Mayor's appointment of Sean Rowe as Deputy City Attorney.

DISCUSSION: Sean Rowe was first elected as the District Attorney for Mineral County in November, 2010. After serving eleven years in office, he announced his resignation in December of 2021 to join Mackedon Law, P.C., beginning in January, 2022.

Prior to entering office, Sean worked as a deputy district attorney, as the Mineral County Public Guardian, and as an attorney in his general practice firm. Sean's career has been focused on seeking justice on behalf of his community and clients, improving governance, and developing community resources.

Before moving to Fallon in 2007, Sean graduated from the University of Idaho College of Law in Moscow, Idaho, following undergraduate and graduate studies in English.

When he has a rare spare moment, Sean is outdoors, hiking in the Sierras and exploring the Great Basin region with his spouse Jessica and their children.
