Calls for Service / Total Incidents Reported

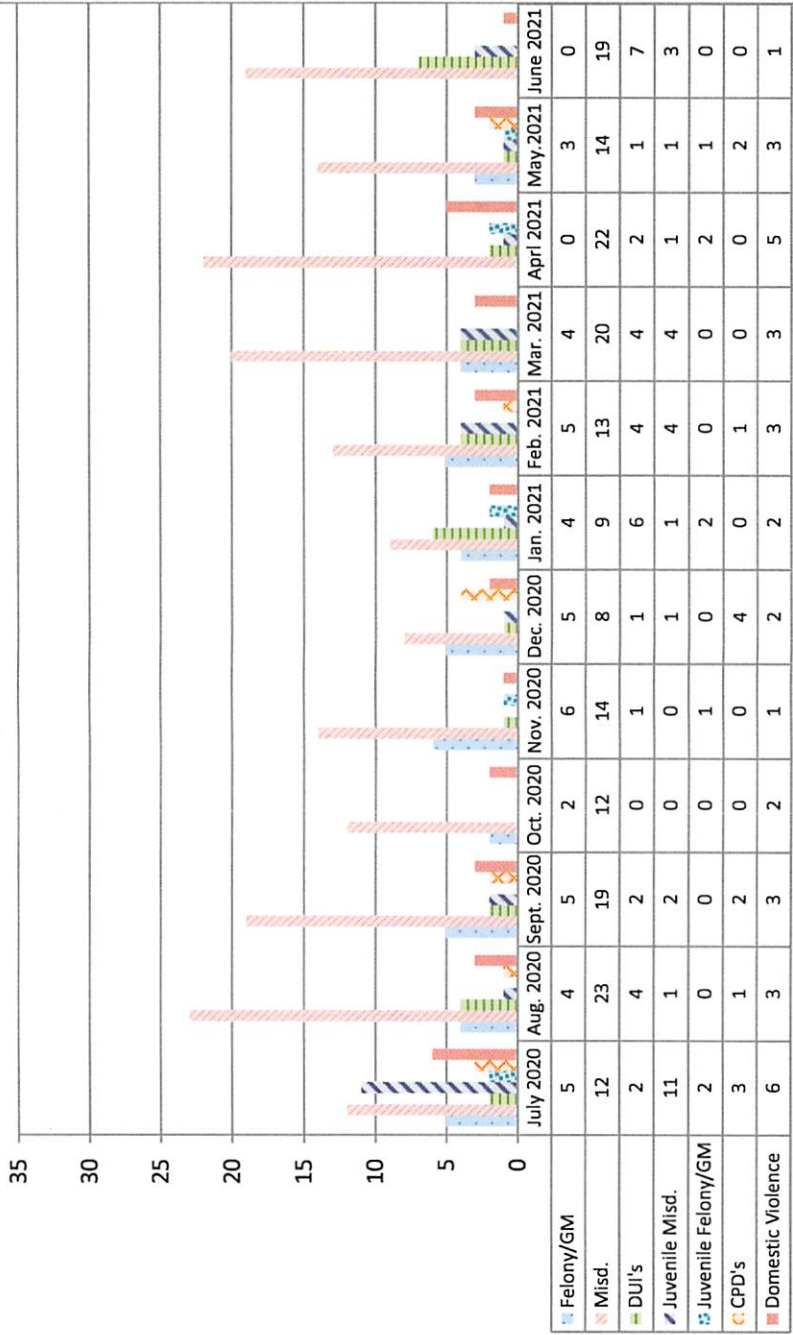

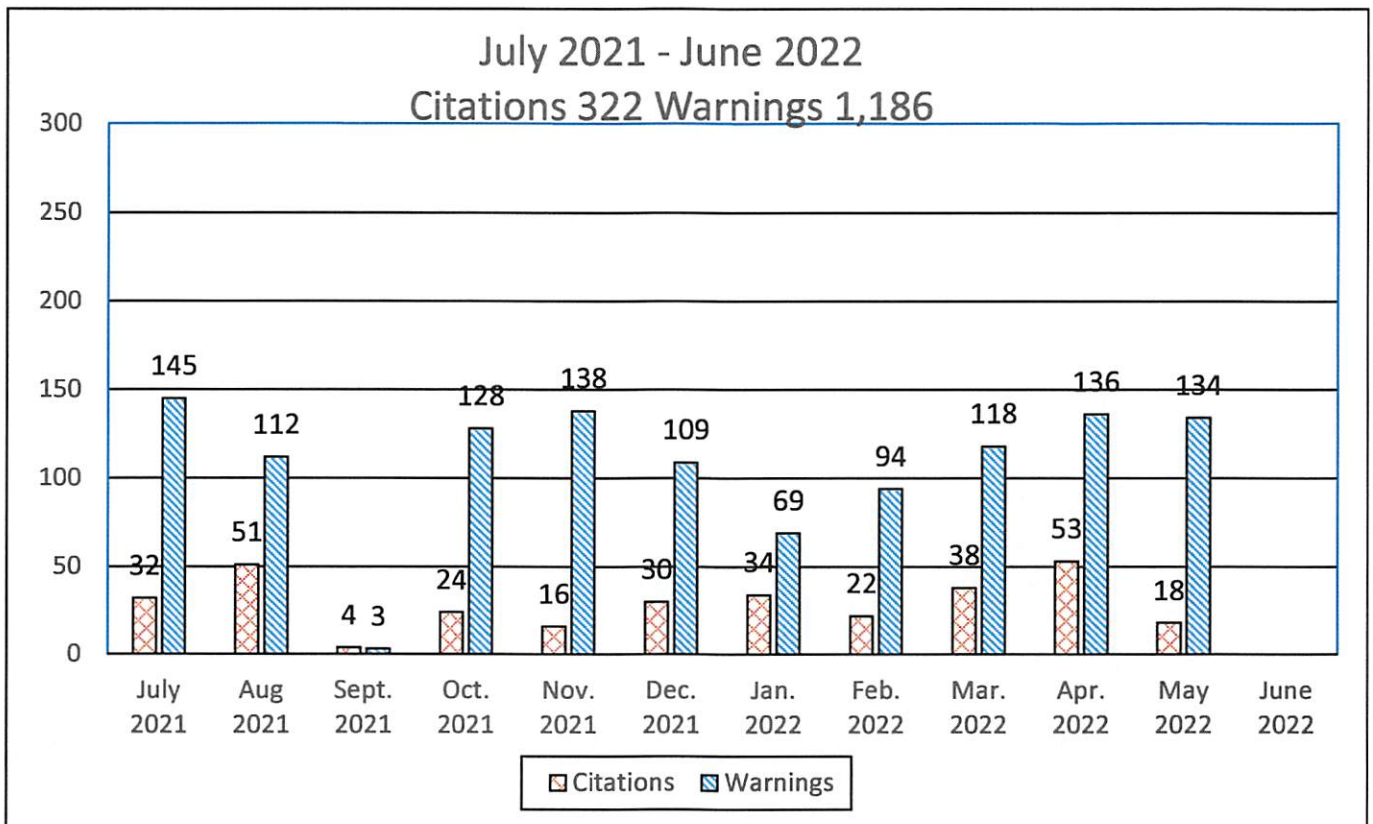
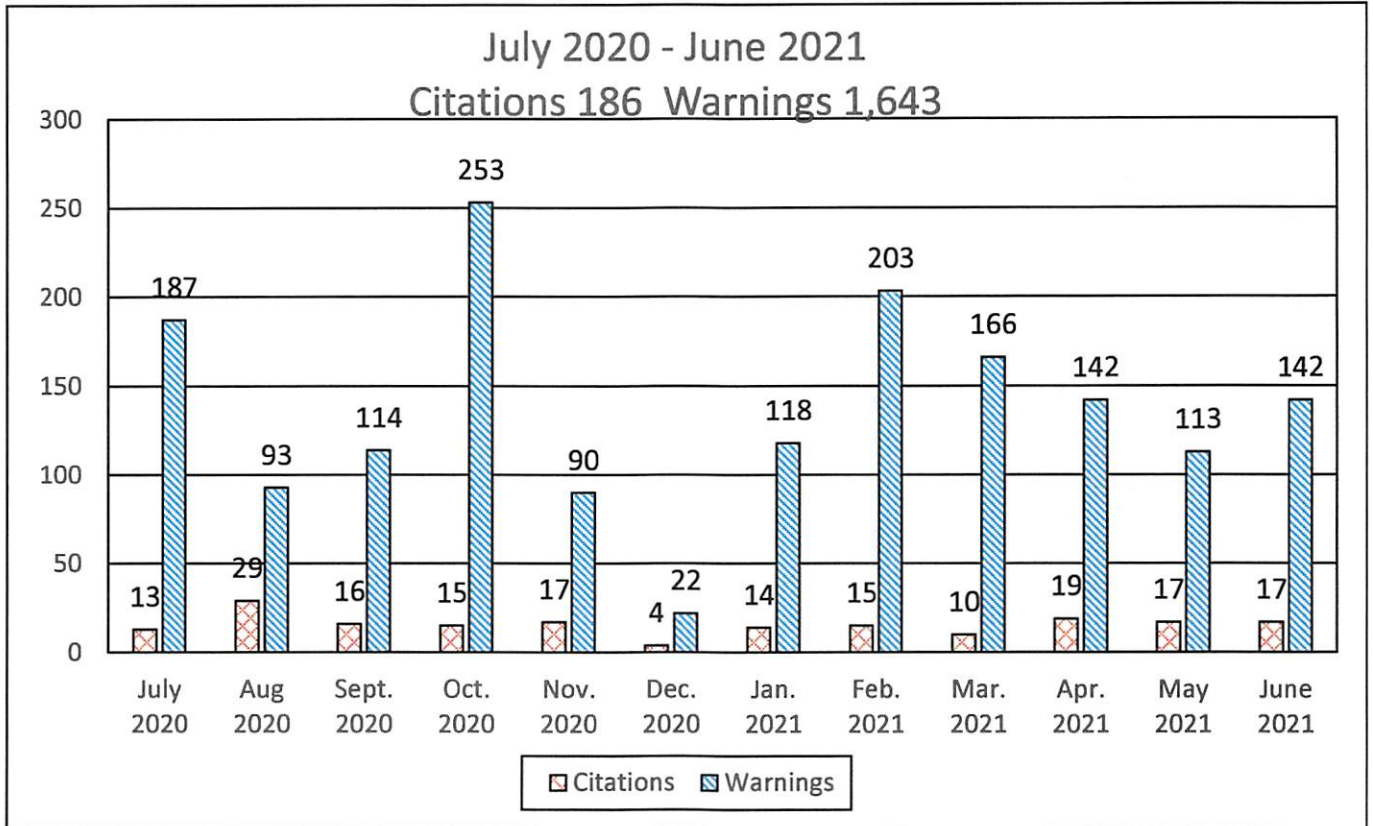
July 2020 - June 2021



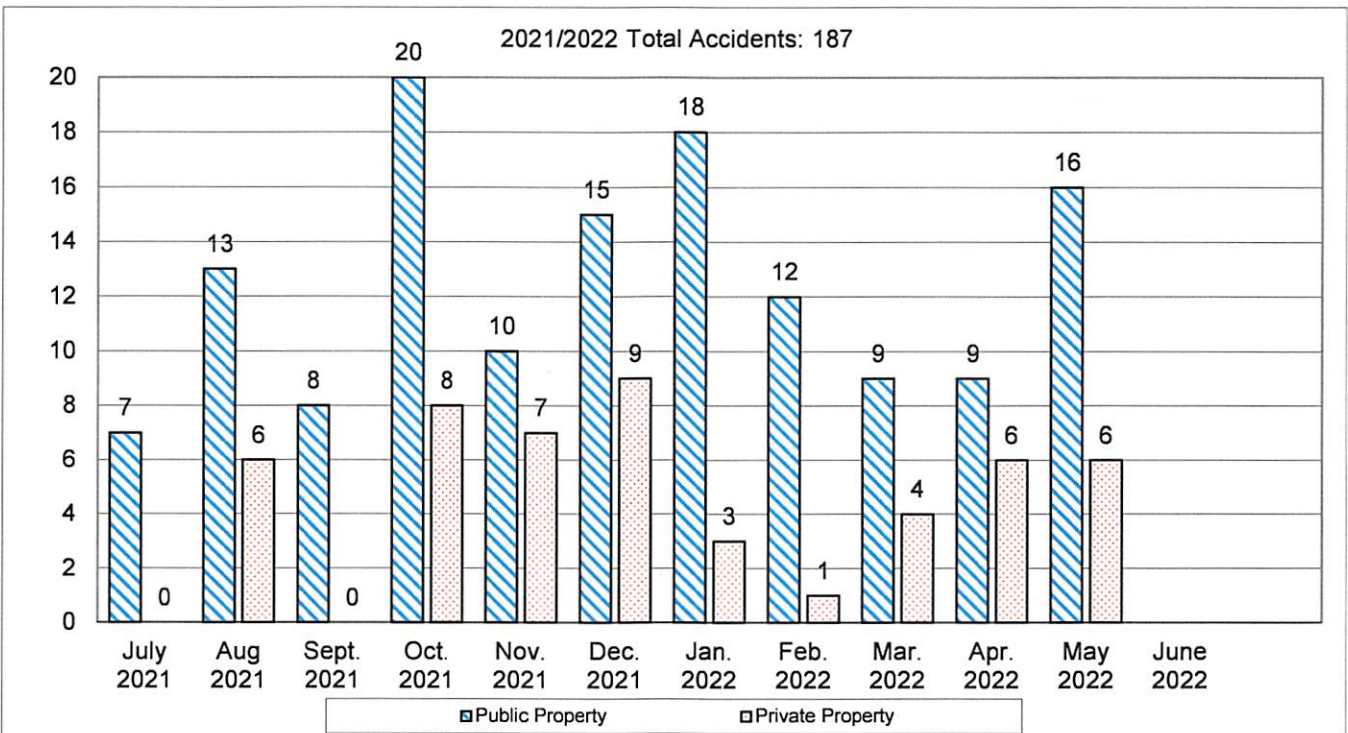
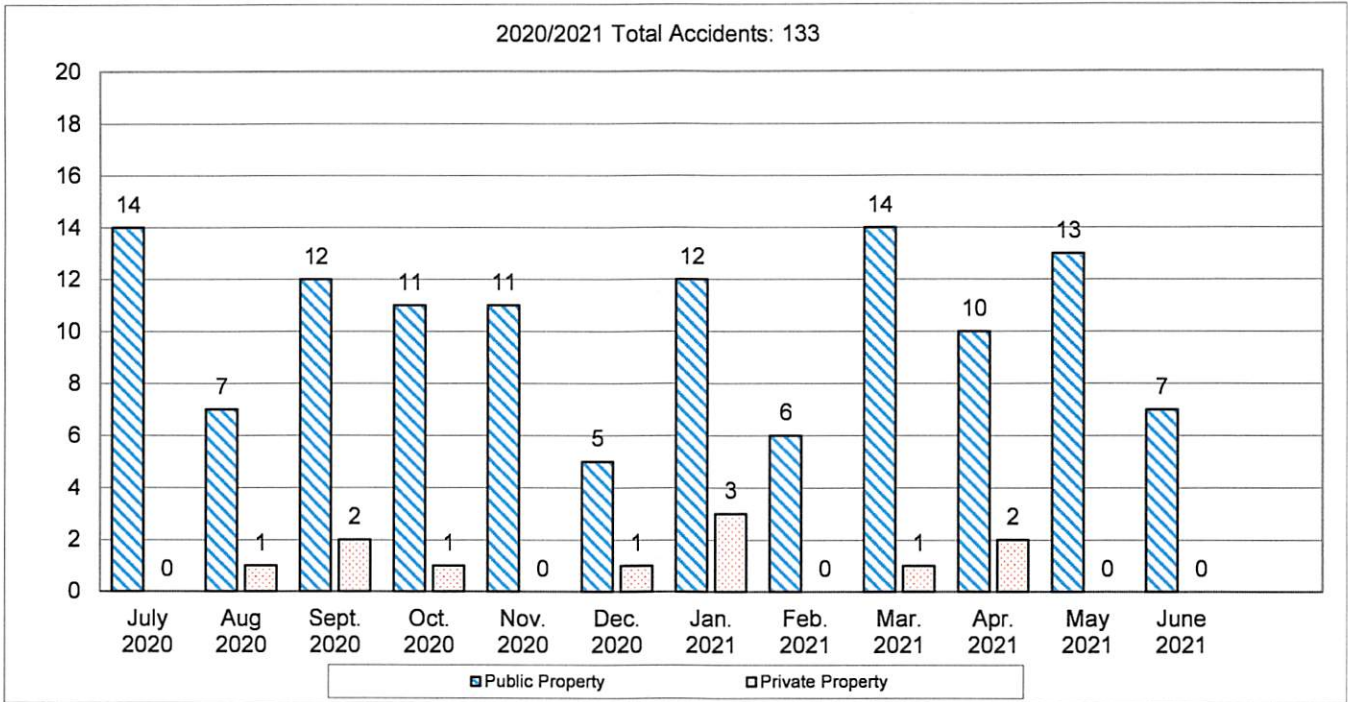

BREAKDOWN OF ARRESTS
