#### **RESOLUTION NO. 22-08**

RESOLUTION OF THE CITY COUNCIL OF FALLON, NEVADA PROVIDING FOR THE TRANSFER OF THE CITY'S 2022 PRIVATE ACTIVITY BOND VOLUME CAP TO THE NEVADA RURAL HOUSING AUTHORITY; AND OTHER MATTERS RELATED THERETO

WHEREAS, pursuant to the provisions of Chapter 348A of the Nevada Revised Statutes ("NRS") and Chapter 348A of the Nevada Administrative Code ("NAC"), there has been allocated to the City of Fallon, in Churchill County, Nevada (the "City," "County" and "State," respectively), the amount of \$498,135.64 in tax-exempt private activity bond volume cap for year 2022 (the "2022 Bond Cap"); and

WHEREAS, the Nevada Rural Housing Authority (the "NRHA"), has requested that the City transfer its 2022 Bond Cap to the NRHA for the purpose of providing a means of financing the costs of single family residential housing that will provide decent, safe and sanitary dwellings at affordable prices for persons of low and moderate income ("Single Family Programs"); and

WHEREAS, the City is a local government as defined by NAC 348A.070; and

WHEREAS, Section 348A.180 of the NAC provides a procedure whereby the City may, by resolution, transfer to any other local government located within the same county, all or any portion of its 2022 Bond Cap; and

WHEREAS, pursuant to NRS 315.983(1)(a), the NRHA is an instrumentality, local government and political subdivision of the State; and

WHEREAS, the NRHA is located within the County, pursuant to NRS 315.963, which defines the NRHA's area of operation as "any area of the State which is not included within the corporate limits of a city or town having a population of 150,000 or more."

Now, THEREFORE, the City Council of the City does hereby find, resolve, determine and order as follows:

- Section 1. Recitals. The recitals set forth herein above are true and correct in all respects.
- Section 2. Transfer of Private Activity Bond Volume Cap. Pursuant to NAC 348A.180, the City hereby transfers its 2022 Bond Cap in the amount of \$498,135.64 to the NRHA for its Single Family Programs.
- Section 3. Use of 2022 Bond Cap. The NRHA will use the 2022 Bond Cap for single family purposes in calendar year 2022 or carry forward any remaining amount according to the Internal Revenue Code of 1986, as amended, for such purposes.

- Section 4. Representative of City. Pursuant to NAC 348A.180(1), the Director of the State of Nevada Department of Business and Industry (the "Director") may contact Sean Richardson, City Clerk Treasurer, City of Fallon, regarding this Resolution at (775) 423-5104 or by email at ELee@FallonNevada.Gov or in writing at 55 West Williams Avenue, Fallon, Nevada 89406.
- Section 5. Additional Action. The Mayor and Clerk of the City are hereby authorized and directed to take all actions as necessary to effectuate the transfer of the 2022 Bond Cap, and carry out the duties of the City hereunder, including the execution of all certificates pertaining to the transfer as required by NAC Ch. 348A.
- Section 6. Direction to the NRHA. The NRHA shall notify the Director in writing as soon as practicable of the occurrence or nonoccurrence of any term or condition that would affect the disposition of the 2022 Bond Cap.
- Section 7. Representative of the NRHA. Pursuant to NAC 348A.180(3), the Director of Business and Industry may contact Diane Arvizo, Director of Homeownership Programs of the NRHA regarding this Resolution at (775) 886-7900 or by email at Diane@NVRural.Org or in writing at Nevada Rural Housing Authority, 3695 Desatoya Drive, Carson City, Nevada 89701.
- Section 8. Obligation of the City. This Resolution is not to be construed as a pledge of the faith and credit of or by the City, or of any agency, instrumentality, or subdivision of the City. Nothing in this Resolution obligates or authorizes the City to issue bonds for any project or to grant approvals for a project or constitutes a representation that such bonds will be issued.
- Section 9. Enforceability. If any section, paragraph, clause or provision of this Resolution shall for any reason be held to be invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause or provision shall not affect any of the remaining provisions of this Resolution. This Resolution shall go into effect immediately upon its passage.





An Ordinance amending the City of Fallon Municipal Code, Title Five "Business Licenses and Regulations", to add Chapter 5.56 entitled "Shopping Carts" which provides for the regulation of shopping carts within the City of Fallon; declares the presence of shopping carts public nuisances in certain situations; requires businesses that provide shopping carts to create a shopping cart retrieval procedure; provides for the retrieval and impounding by the City or its agents of shopping carts in certain situations; and other matters properly related thereto.

WHEREAS, damaged, dismantled, and/or abandoned shopping carts on public or private property create conditions that promote blight and deterioration within the City;

WHEREAS, the City Council believes that such shopping carts constitute a nuisance, create potential hazards to the health and safety of the public, and interfere with pedestrian and vehicular traffic; and

WHEREAS, after discussion and consideration, the City Council finds that establishing regulations concerning the abandonment and recovery of shopping carts is in the best interest of the City and will promote the health and welfare of the citizens and the general public.

Therefore, the City Council of the City of Fallon, Nevada, do ordain as follows:

SECTION ONE: that Title Five "Business Licenses and Regulations" be amended, adding Chapter 5.56 which shall read as follows:

Chapter 5.56 "Shopping Carts"

5.56.010 - Definitions.

For the purposes of this chapter, the following terms, phrases, words and their derivations shall have the meaning given herein. When not inconsistent with the context, words used in the present tense include the future, words in the plural number include the singular number, and words in the singular number include the plural number. The word "shall" is always mandatory and not merely directory.

- A. "City" means the City of Fallon.
- B. "Premises" means the interior of a business establishment, and all exterior landscaped areas, pedestrian areas and sidewalks adjacent to a business establishment, and the designated parking lot area provided by a business establishment for its customers to park their automobiles or other means of transportation while they patronize the business establishment. The premises includes the entire parking area used by a multistore complex or shopping center wherein such business establishment is located.
- C. "Private property" means all real property in the city, but excluding public property.

- D. "Public property" means all real property owned, leased or occupied by the city, all real property in which the city has a possessory interest, and any easement granted to the city for public purposes, including, without limitation, public streets, parks, alleys, sidewalks, flood control channels, and any other real property within the city owned, leased or occupied by any governmental entity.
- E. "Shopping Cart" means a basket, or similar device, that is mounted on wheels and is generally used by customers and patrons in retail or wholesale business establishments for the purpose of transporting goods of any kind within the premises thereof. The term includes any constituent part of a shopping cart, as well as a shopping cart that is dismantled or not in working order.
- F. "Shopping cart owner" means, with respect to any shopping cart:
  - a. The legal owner of such shopping cart;
  - b. the owner or operator of a business establishment that is authorized by the legal owner of such shopping cart to provide such shopping cart for use by customers and patrons at the premises of the business establishment; and
  - c. The authorized agents and employees of the persons listed in subsections (a) and (b).

5.56.020 Shopping carts on public property and private property declared a nuisance

A shopping cart placed, located, left, situated or found upon any public property or any private property (excluding the premises at which the shopping cart owner provides such shopping cart for use by customers), is a public nuisance, which the city or its authorized agents may abate in accordance with this chapter and applicable law.

5.56.030 Shopping cart owners to implement shopping cart management and retrieval plan

Shopping cart owners shall provide to the City a shopping cart plan which shall enumerate its plans to manage and retrieve shopping carts. Shopping cart management plans shall provide for, at a minimum, the following:

- A. Measures to contain its shopping carts within the premises of its business establishment and/or to prevent any unauthorized person from removing one or more shopping carts from such premises. Permitted measures include any or all of the following:
  - a. A wheel locking mechanism installed on all shopping carts and used in conjunction with an electronic barrier along the perimeter of the premises, which is activated when a shopping cart crosses the electronic barrier;
  - b. A physical barrier, such as bollards, restricting shopping carts to a specific area of the premises;
  - c. A mechanical system requiring a reasonable deposit to use a shopping cart;
  - d. Shopping carts equipped with a protruding arm or similar device prohibiting a cart from being removed from the interior of a business establishment; or
  - e. Any other similar method that prevents the removal of shopping carts from the premises.

- B. Measures to retrieve shopping carts from public and private property. A shopping cart owner is exempt from the requirements of subsection "A" of this Section during any period of time in which such shopping cart owner implements, enforces and utilizes measures for retrieving shopping carts from public property daily and returning such shopping carts promptly to the shopping cart owner. Permitted measures include any or all of the following:
  - Entering into a written contract with a cart retrieval service requiring the daily retrieval of shopping carts from public and private property, and the return of such shopping carts to the shopping cart owner;
  - b. Daily retrieval by the shopping cart owner of its shopping carts from public and private property; or
  - c. Any other similar method that results in the daily retrieval of shopping carts from public and private property.

#### 5.56.040 Retrieval and impoundment by the City

The City may retrieve and impound any shopping cart located on public or private property. A shopping cart recovered by the City will be released to the owner, or designee, upon payment to the City of a recovery fee of fifteen dollars (\$15.00) per shopping cart.

#### 5.56.050 Disposal of abandoned shopping carts

A Shopping cart impounded shall be held for a period of not more than thirty (30) days to allow for retrieval by the shopping cart owner. In the event the shopping cart is not reclaimed by the owner within such thirty (30) days period of impoundment, the City shall sell or dispose of the same. The City may impose, pursuant to this chapter, storage fees and costs of five dollars per day (\$5.00/day) per cart impounded by the City.

SECTION TWO: If any section, article paragraph, sentence, clause, phrase or word in this ordinance, or application thereto any persons or circumstances is held invalid or unconstitutional by a Court of competent jurisdiction, such holding shall not affect the validity of the remaining portions of this ordinance; and the City Council hereby declares it would have passed such remaining portions of this Ordinance despite such invalidity, which remaining portions shall remain in full force and effect.

This ordinance shall become effective after its passage, approval and publication as required by law.



Bill No. 788 Ordinance No. 773

An Ordinance amending the City of Fallon Municipal Code, Title Five "Business Licenses and Regulations", to add Chapter 5.56 entitled "Shopping Carts" which provides for the regulation of shopping carts within the City of Fallon; declares the presence of shopping carts public nuisances in certain situations; requires businesses that provide shopping carts to create a shopping cart retrieval procedure; provides for the retrieval and impounding by the City or its agents of shopping carts in certain situations; and other matters properly related thereto.

WHEREAS, damaged, dismantled, and/or abandoned shopping carts on public or private property create conditions that promote blight and deterioration within the City;

WHEREAS, the City Council believes that such shopping carts constitute a nuisance, create potential hazards to the health and safety of the public, and interfere with pedestrian and vehicular traffic; and

WHEREAS, after discussion and consideration, the City Council finds that establishing regulations concerning the abandonment and recovery of shopping carts is in the best interest of the City and will promote the health and welfare of the citizens and the general public.

Therefore, the City Council of the City of Fallon, Nevada, do ordain as follows:

SECTION ONE: that Title Five "Business Licenses and Regulations" be amended, adding Chapter 5.56 which shall read as follows:

Chapter 5.56 "Shopping Carts"

5.56.010 – Definitions.

For the purposes of this chapter, the following terms, phrases, words and their derivations shall have the meaning given herein. When not inconsistent with the context, words used in the present tense include the future, words in the plural number include the singular number, and words in the singular number include the plural number. The word "shall" is always mandatory and not merely directory.

- A. "City" means the City of Fallon.
- B. "Premises" means the interior of a business establishment, and all exterior landscaped areas, pedestrian areas and sidewalks adjacent to a business establishment, and the designated parking lot area provided by a business establishment for its customers to park their automobiles or other means of transportation while they patronize the business establishment. The premises includes the entire parking area used by a multistore complex or shopping center wherein such business establishment is located.
- C. "Private property" means all real property in the city, but excluding public property.

- D. "Public property" means all real property owned, leased or occupied by the city, all real property in which the city has a possessory interest, and any easement granted to the city for public purposes, including, without limitation, public streets, parks, alleys, sidewalks, flood control channels, and any other real property within the city owned, leased or occupied by any governmental entity.
- E. "Shopping Cart" means a basket, or similar device, that is mounted on wheels and is generally used by customers and patrons in retail or wholesale business establishments for the purpose of transporting goods of any kind within the premises thereof. The term includes any constituent part of a shopping cart, as well as a shopping cart that is dismantled or not in working order.
- F. "Shopping cart owner" means, with respect to any shopping cart:
  - a. The legal owner of such shopping cart;
  - b. the owner or operator of a business establishment that is authorized by the legal owner of such shopping cart to provide such shopping cart for use by customers and patrons at the premises of the business establishment; and
  - c. The authorized agents and employees of the persons listed in subsections (a) and (b).

5.56.020 Shopping carts on public property and private property declared a nuisance

A shopping cart placed, located, left, situated or found upon any public property or any private property (excluding the premises at which the shopping cart owner provides such shopping cart for use by customers), is a public nuisance, which the city or its authorized agents may abate in accordance with this chapter and applicable law.

5.56.030 Shopping cart owners to implement shopping cart management and retrieval plan

Shopping cart owners shall provide to the City a shopping cart plan which shall enumerate its plans to manage and retrieve shopping carts. Shopping cart management plans shall provide for, at a minimum, the following:

- A. Measures to contain its shopping carts within the premises of its business establishment and/or to prevent any unauthorized person from removing one or more shopping carts from such premises. Permitted measures include any or all of the following:
  - a. A wheel locking mechanism installed on all shopping carts and used in conjunction with an electronic barrier along the perimeter of the premises, which is activated when a shopping cart crosses the electronic barrier;
  - b. A physical barrier, such as bollards, restricting shopping carts to a specific area of the premises;
  - c. A mechanical system requiring a reasonable deposit to use a shopping cart;
  - d. Shopping carts equipped with a protruding arm or similar device prohibiting a cart from being removed from the interior of a business establishment; or
  - e. Any other similar method that prevents the removal of shopping carts from the premises.

- B. Measures to retrieve shopping carts from public and private property. A shopping cart owner is exempt from the requirements of subsection "A" of this Section during any period of time in which such shopping cart owner implements, enforces and utilizes measures for retrieving shopping carts from public property daily and returning such shopping carts promptly to the shopping cart owner. Permitted measures include any or all of the following:
  - a. Entering into a written contract with a cart retrieval service requiring the daily retrieval of shopping carts from public and private property, and the return of such shopping carts to the shopping cart owner;
  - b. Daily retrieval by the shopping cart owner of its shopping carts from public and private property; or
  - c. Any other similar method that results in the daily retrieval of shopping carts from public and private property.

#### 5.56.040 Retrieval and impoundment by the City

The City may retrieve and impound any shopping cart located on public or private property. A shopping cart recovered by the City will be released to the owner, or designee, upon payment to the City of a recovery fee of fifteen dollars (\$15.00) per shopping cart.

#### 5.56.050 Disposal of abandoned shopping carts

A Shopping cart impounded shall be held for a period of not more than thirty (30) days to allow for retrieval by the shopping cart owner. In the event the shopping cart is not reclaimed by the owner within such thirty (30) days period of impoundment, the City shall sell or dispose of the same. The City may impose, pursuant to this chapter, storage fees and costs of five dollars per day (\$5.00/day) per cart impounded by the City.

SECTION TWO: If any section, article paragraph, sentence, clause, phrase or word in this ordinance, or application thereto any persons or circumstances is held invalid or unconstitutional by a Court of competent jurisdiction, such holding shall not affect the validity of the remaining portions of this ordinance; and the City Council hereby declares it would have passed such remaining portions of this Ordinance despite such invalidity, which remaining portions shall remain in full force and effect.

This ordinance shall become effective after its passage, approval and publication as required by law.

#### **SUMMARY OF GRANT PERFORMANCE, August 2022**

#### COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM

Since 1982, the City of Fallon has received twenty-five Community Development Block Grants (CDBG). A brief description and status of these grants is found below.

- a. In 1982, a grant (CDBG/82/015) was received in the amount of \$10,000. The project provided access to City Hall for the handicapped which was not previously available. The project was successfully closed out in May, 1984.
- b. In 1988, a grant (CDBG/88/085) was received in the amount of \$33,000. The project involved the construction of a new restroom and the remodeling of another ADA accessible restroom within City Hall. \$22,369.13 of the grant was used and the remaining funds were returned. The project was successfully closed out in November, 1990.
- c. In 1991, a grant (CDBG/91/135) was received in the amount of \$137,000. This grant was utilized to replace a water line in the downtown business area of Fallon. The project was successfully closed out in 1996.
- d. In 1993, a grant (CDBG/93/345) was received in the amount of \$61,637. This grant was utilized to replace a water transmission line running down North Maine Street. The project was successfully closed out in 1999.
- e. In 2000 a housing grant (CDBG/00/HS/002) was received in the amount of \$52,852.00. The project involved the rehabilitation of substandard housing. \$8,194.63 of the grant was used and the remaining funds were returned. The project was successfully closed out in 2005.
- f. In 2003, a grant (CDBG/03/PCB/004) was received for a feasibility study in the amount of \$20,000.00. The project evaluated the feasibility of providing water and sewer service to areas immediately South of Fallon. The project was successfully closed out in 2010.
- g. In 2004, a grant, (CDBG/04/ED/004), was received on behalf of the Nevada Micro-enterprise Initiative in the amount of \$50,000.00. The funds were used as operating funds to assist small businesses in Nevada. \$37,228.99 of the grant was used and the remaining funds were returned. The project was successfully closed out in January, 2012.
- h. In 2004, a grant, (CDBG/04/ED/005), was received on behalf of the Nevada Micro-enterprise Initiative in the amount of \$70,000.00. The funds were used as loan funds to assist small businesses in Nevada. \$35,000.00 of the grant was used and the remaining funds were returned. The project was successfully closed out in January, 2012.

- i. In 2004, a grant, (CDBG/04/020), was received on behalf of Community Business Resource Center (CBRC) in the amount of \$160,000.00. The funds were used for general operating costs. CBRC provides technical assistance and training for small businesses. The project was successfully closed out in January, 2012.
- j. In 2004, a grant, (CDBG/04/007), was received on behalf of Churchill Association for Retarded Citizens (Fallon Industries) in the amount of \$168,000.00. The grant was amended in 2005 with an additional \$20,000.00. The project is being used to provide additional facilities for the Churchill Association of Retarded Citizens. \$26,000.00 of the grant was de-obligated and the remaining funds are being used. The project was successfully closed out on May 21, 2010.
- k. In 2007, a grant, (CDBG/07/PF/006), was received on behalf of the Coalition of Senior Citizens in the amount of \$130,000.00. The project remodeled their facility at 310 East Court Street. Of the grant total, \$7,212.00 was de-obligated and returned to CDBG, while the rest was used. The project was successfully closed out on May 21, 2010.
- I. In 2007, a grant, (CDBG/07/PCB/004), was received on behalf of the Churchill Economic Development Authority in the amount of \$50,000.00. The project is a Hometown Competitiveness (HTC) program designed to help build leadership in the community. Of the grant total, \$8,561.05 was de-obligated and returned to CDBG, while the rest was used. The project was successfully closed out on May 6, 2010.
- m. In 2008, a \$250,000.00 grant, (CDBG/08/AQ/001), was received of behalf of Churchill Council on Alcohol and Other Drugs, which is doing business as New Frontier Treatment Center. The project will help acquire a new building from which to operate the treatment center. The project was successfully closed out in 2008.
- n. In 2009, a grant, (CDBG/09/PF/009), in the amount of \$100,000.00 was received for playground equipment installation at Oats Park. Of the grant total, \$4,223.00 was de-obligated and returned to CDBG, while the rest was used. The project was successfully closed out on August 3, 2010.

- q. In 2011, a grant, (CDBG/11/PF/12), in the amount of \$100,000.00 was received for the landscape renovations in Oats Park. The park was regraded and new sod laid. All grant funds were used and the project was successfully closed out on April 29, 2013.
- r. In 2013, a grant, (CDBG/13/PF/04,), in the amount of \$135,000.00 was received for ADA improvements at the Outdoor Pool. Major interior improvements were made to the building as well as the creation of additional ADA access. All grant funds were used and the project was successfully closed out on August 13, 2014.
- s. In 2014, a grant, (CDBG/14/PF/08), in the amount of \$112,500.00 was received for ADA improvements at the Outdoor Pool, Phase 2. \$9,297.55 was deobligated and returned to CDBG, while the rest was used. The project was successfully closed out November on 6, 2015.
- t. In 2016, a grant, (CDBG/16/AQ/06), in the amount of \$300,000.00 was received as a pass-thru grant to Fallon Community Theatre for the purchase of Fallon Theatres, 71 South Maine Street. The project was successfully closed out February 28, 2017.
- u. In 2016, a grant, (CDBG-16/2-PS-20), in the amount of \$29,568.00 was received as a pass-thru grant to Fallon Food Hub for the purchase of equipment to expand capacity to process food for the area. The project has been officially closed.
- v. In 2017, a grant, (CDBG-17-AQ-02), in the amount of \$107,000.00 was received as a pass-thru grant to Fallon Food Hub for the purchase of 495 South Maine Street. The project is currently underway. The project is closed out.
- w. In 2019, a grant, (CDBG-19-PF-04), in the amount of \$630,444 was received for reconstructing portions of Front Street. The project included a full roadway reconstruction as well as the installation of curb, gutter and sidewalk. This project was completed in 2021 and in the process of being closed.
- x. In 2021, a grant, (CDBG-21-PF-04), in the amount of \$885,462.50 was allocated for reconstructing portions of North Broadway and North Sherman Street. The project includes a full roadway reconstruction as well as the installation of curb, gutter and sidewalk. This project is out to bid and is expected to be completed in 2022/2023.
- y. In 2022, a grant, (CDBG-22-PF-08), in the amount of \$405,045 was allocated for reconstructing a portion of Court Street. The project includes a full roadway reconstruction as well as the installation of curb, gutter and sidewalk.
