Mayor Tedford was not present for this meeting and the meeting was called to order by Mayor Pro Tem Kelly Frost at 9:00 a.m. Mayor Pro Tem Kelly Frost led the Pledge of Allegiance.

Mayor Pro Tem Kelly Frost inquired if the agenda had been posted in compliance with NRS requirements.

Deputy City Clerk Elsie Lee advised that the agenda was posted in compliance with the NRS requirements.

Public Comments

Mayor Pro Tem Frost inquired if there were any public comments. She noted that comments are to be general in nature, not relative to any agenda items. No action may be taken on a matter raised under this item until the matter has been specifically included on an agenda as an item upon which action will be taken.

Geoff Nell of 261 Serpa Place said that it is predicted to be 82 degrees today. Wow, getting close to shorts and short sleeved shirts. Well, I would like to begin with reading out of the book of Proverbs and this is regarding a believer in Christ, wisdom. I am 'gonna start with verse 32 through verse 36. **Consideration and possible approval of Council meeting minutes for June 19, 2018.
(For possible action)**

Mayor Pro Tem Frost said that staff has presented the meeting minutes for the Council's meeting on June 19, 2018. These meeting minutes took an extended amount of time because they consist of a word-for-word transcript on the meeting that took place that evening. Because of the importance of the record for this meeting, the City hired a Court Reporter to transcribe the meeting audio. After receiving the transcripts, City Staff also reviewed the transcript for accuracy. This took a significant amount of time, but Staff felt it was important to have an accurate record of the hearing. Have the Councilmembers had the opportunity to review the minutes?

All Councilmembers responded yes.

Mayor Pro Tem Frost asked if there was any questions or discussion for the Council.

No comments were noted.

Mayor Pro Tem Frost asked if there were any public comments about the agenda item.

Geoff Nell said he will concur. It is a very hard decision. But it seems to be we threw our hands up. We just gave up. You know, there is legislation now, looking at new legislation for the State, next year. But at a time to introduce bills, to refute the evil that they're promoting. And I hope you do something like that. You know, stop the hate crimes bill, where it says to sexualize our children.

Mayor Pro Tem Frost interrupted Mr. Nell and reminded him that this is regarding the agenda item on the Council meeting minutes and asked if he had a comment on that.

Consideration and possible approval of plan of correction to prevent the recurrence of statute and regulation violations as reported in Note 2 of the Annual Comprehensive Financial Report for the Year Ended June 30, 2021. (For Possible Action)

City Clerk Sean Richardson stated that pursuant to NRS 354.6245, the City shall advise the Department of Taxation to what action has been taken to prevent recurrence of each violation of law or regulation, or to correct continuing violations. The enclosed memo to the Mayor and Council outlines the details of the plan of correction for each violation. If approved, this plan of correction will be forwarded to the Department of Taxation to comply with the statutory requirement.

Councilwoman Kent asked about a statement at the bottom that states the staff will be more conservative with their estimates for May and June, but is conservative the correct verbiage? Would the word liberal be more appropriate since we would need to be higher with the estimates?

City Clerk Sean Richardson said that yes, higher is what he was going for and probably didn't use the best terminology. Before I send it over to the Department of Taxation, I can change that wording. I also plan to write a separate letter to the Department of Taxation. I can definitely change that verbiage to make it clearer.

Mayor Pro Tem inquired if there were any public comments.

Councilwoman Kent motioned to approve the plan of correction to prevent the recurrence of statute and regulation violations as reported in Note 2 of the Annual Comprehensive Financial Report for the Year Ended June 30, 2021. seconded by Councilman Richardson. The motion carried on a 3-0 vote by the Fallon City Council.

No comments were noted.


Executive Session
