RECOMMENDED COUNCIL ACTION: Motion to confirm the Mayor's appointment of John Riley as Police Captain.

DISCUSSION: John began his career with the Fallon Police Department in 2003 as a Dispatcher. He attended the POST Academy in January 2005 and began his career as a police officer, and acted as the fill-in School Resource Officer. In 2006 he was assigned to the newly formed position of Domestic Violence Investigator where he was also a member of a special committee on domestic violence that developed and implemented the Domestic Violence Investigation Guidelines, that has been used as a pocket guide throughout the state. John taught Teen Dating Violence for several years in Churchill County Middle and High Schools. While in that role, John also co-authored the Investigating Domestic Violence Crimes in Nevada Field Guide. John served in investigations until 2012 when he returned to Patrol.

On May 4, 2015 John was promoted to Sergeant of the patrol division, supervising the Fallon Police Department Explorer program, day to day activities, maintaining patrol vehicles and acting as a mentor to other officers. John received the Life Saving Medal of Honor, twice, for his service to the Fallon community, and served on the Nevada Attorney General's Special Task Force for Domestic Violence.

John has previously taught Patrol Response to Domestic Violence, Patrol Procedures and Rights of Victims at the POST Police Academy for many years.

In June 2018, John was assigned as the Administrative Sergeant where he supervises the communications department, manages department vehicles and technology, assists with CALEA compliance, approves patrol call cards and assists with general recommendations for the patrol division.
