DESCRIPTION: Upon approval, the project would allow for the two existing tennis courts at Oats Park to be converted into six pickleball courts.

Construction elements of the project include: Civil improvements in support of the new courts, seating areas with shade, ADA concrete walkway improvements around the exterior of the tennis courts, new fencing and gates, water bottle filling stations, state of the art court surfacing, netting and new LED lighting.

BACKGROUND: This project was released for public bid on March 31, 2023 and was advertised in the Fallon Post in accordance with NRS 338.1385. A pre-bid meeting was held on April 6, 2023. One (1) bid was received and opened on April 20, 2023 as further described in the attached documents.
